Most of the services provided are on an outpatient basis. Clients meet with professional staff in the Clinic office in Green Lake. All client information is held in strictest confidence. When more severe or chronic problems require hospitalization, residential treatment, halfway house, etc., referral is made to one of the Board contracted facilities providing these services.
