**LAND USE REGULATIONS**

**The Green Lake County Zoning Ordinance** shall apply in the Towns of Berlin, Brooklyn, Green Lake, Mackford, Manchester, Marquette and the **Shoreland Protection Ordinance** shall apply in **ALL THE TOWNS** in Green Lake County. A land use permit is required for construction and development activities in these areas and is valid for 1 year from the date of issuance.

**“Shorelands” are defined as being:** Those lands lying within 1,000 feet of the ordinary high water mark of a lake, pond or flowage; and those lands lying within 300 feet of the Ordinary high water mark of a river or stream or to the landward side of the floodplain or Whichever distance is greater.”

Additional information and applications for permits can be obtained from the Code Enforcement Office, Courthouse, Green Lake, WI 54941 from 8:00 AM to 4:30 PM Monday through Friday.
