The Wisconsin Department of Transportation (DEPARTMENT) authorizes the maintenance project herein described, and the above designated County (COUNTY), represented by its County Highway Committee and/or Highway Commissioner, agrees to perform such operations and furnish such materials as listed in the Schedule of Work Items and complete the work by the date indicated above. It is understood that the highway maintenance services as authorized under this AGREEMENT shall be accomplished in compliance with state and federal law. It is acknowledged that this AGREEMENT will be consistent with Section 5, Performance Based Maintenance as agreed to under the Memorandum of Understanding between the DEPARTMENT, WCHA and WTBA dated September 13, 2015. Authorization for the payment of this work is found under s. 84.07 (2) (b). Payment for services and materials provided under this AGREEMENT shall be made within 30 days of presentation of final county invoice and mutually agreed measurement of quantities and acceptance by the department of work performed.

In connection with the services provided under this AGREEMENT, the COUNTY agrees not to discriminate against any employee or applicant for employment because of sex, age, race, religion, color, handicap, physical condition, developmental disability as defined in s. 51.05 (5), sexual orientation, or national origin. This provision shall include, but not limited to the following: employment upgrading, demotion or transfer, recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The COUNTY further agrees to post in a conspicuous place, available for employees and applicants for employment, notices setting forth these provisions.

It is understood all work performed by the COUNTY as authorized under this AGREEMENT shall adhere to the guidelines, procedures, and standards set forth by the DEPARTMENT in the Special Provisions for the PBM 2016 Pilot Program; State of Wisconsin, Standard Specifications for Highway and Structure Construction, 2016 Edition; the Highway Maintenance Manual; and the AGREEMENT supplemental special provisions. If there is a discrepancy between documents, the supplemental special provisions shall govern. If there is a discrepancy between the remaining documents, the governing order is as outlined in 105.4 of the Standard Specifications for Highway and Structure Construction. Both the DEPARTMENT and the COUNTY recognize that based upon unit price reimbursement the COUNTY may generate revenues over expenditures or may have expenditures over revenues.

Work not listed in the Schedule of Work Items will not be subject to reimbursement unless such work has been formally authorized and approved by an appropriate project change order. The unit prices quoted for the work items are agreed to be the prices used in extending the quantities for work performed. A change order is the written authorization by the DEPARTMENT covering work not otherwise provided for in the AGREEMENT. This may include: work that does not appear in the AGREEMENT as a specific work item accompanied by a unit price, differing site conditions, significant changes in the character of work, additions of work, deletion of work, and revisions or amendments to the AGREEMENT. The work items and units agreed upon and listed in the schedule below may vary from planned quantity by up to 15% without requiring a change order to the AGREEMENT.

If the project requires railroad flagging, the DEPARTMENT will reimburse the COUNTY 100% of the costs for flagging services provided by railroads.

The DEPARTMENT may terminate this AGREEMENT before expiration for reasons beyond control of the DEPARTMENT or default. Once determining that termination is in the DEPARTMENT'S or public interest, the DEPARTMENT will provide a written termination notice specifying the extent of termination and the effective date. In the event the AGREEMENT is terminated by the DEPARTMENT, the COUNTY shall be paid the reasonable value for services and materials rendered to the DEPARTMENT up to the time of termination. Cause for default shall be the COUNTY's failure to perform work with sufficient workers, equipment, or materials, or complete work within the AGREEMENT time specified.

The COUNTY may terminate before expiration of this AGREEMENT for "good cause" or default. Upon termination for good cause by the COUNTY, the COUNTY must continue service until the DEPARTMENT secures a replacement provider, which the DEPARTMENT will seek and pursue immediately upon receiving a written termination notice from the COUNTY. If the DEPARTMENT does not secure a replacement provider within 45 days the COUNTY is relieved of its service. The COUNTY must compensate the DEPARTMENT for any harm caused by early termination. Cause for default shall be the DEPARTMENT's failure to make payments to the COUNTY as required by this AGREEMENT.

The Department will within 7 days approve or deny the use of the materials based on the contract requirements. Do not incorporate any materials in the contract that have not been approved by the Department.

Holiday Work Restrictions.

Do not perform work on, nor haul materials of any kind along or across any portion of the highway carrying STH 44 traffic, and entirely clear the traveled way and shoulders of such portions of the highway of equipment, barricades, signs, lights, and any other material that might impede the free flow of traffic during the following holiday periods:

From noon Thursday, May 26, 2015 to 6:00 AM Tuesday, May 31, 2016 for Memorial Day; From noon Thursday, June 30, 2016 to 6:00 AM Tuesday, July 5, 2016 for Independence Day; From noon Thursday, Sept. 1, 2016 to 6:00 AM Tuesday, Sept. 6, 2016 for Labor Day;

3. Public Convenience and Safety - Lane Closure Notification.

At least 14 days prior to the anticipated start of work; submit to the Department for approval a schedule of closures necessary for completion of the contract. Identify general information including the construction activity requiring a closure, location of closure, type of closure, duration of closure, and times of closure.

Enter all closures into the Wisconsin Lane Closure System (LCS) and request approval for the closure from the Department. For all LCS entries and approval requests, provide the minimum advance notification to the Department for the following closures:

Verify that the closure is approved in the Wisconsin Lane Closure System prior to implementing the closure. 4. Crack Routing and Sealing

Supplement the Crack Routing and Sealing, Pilot Program Specifications for Performance Based Maintenance, 2016 Edition with the following:

Weather Limitations

Sealant materials shall only be placed during a period of rising temperature after the air and surface temperature in the shade and away from artificial heat sources has reached 40 degrees Fahrenheit and indications are for a continued rise in temperature. During a period of falling temperatures, which may fall below 40 degrees Fahrenheit, placement of the sealant material shall be suspended until the above conditions are met.

Do not place sealant material if weather conditions are raining or wet. Should the sealant be placed and rain should fall before the sealant has properly cured, remove and replace the wet/contaminated sealant.

Documentation

Provide the following documents to the Department within a month after approving the contract but at least 14 calendar days before the intended start date:

- 1. Manufacturers product installation instructions.
- 2. Material product data sheet.

Melting kettle production data sheets shall be developed, completed, and submitted daily for each kettle on the project with the following information.

- 1. Date, county, highway route number and highway segment.
- 2. Weather conditions at morning, mid-day and afternoon intervals.
- 3. Kettle number and model, ambient air and pavement temperature in degrees Fahrenheit at the beginning of the day, mid-day and end of day.
- 4. Kettle temperature in degrees Fahrenheit once an hour during working production.
- 5. Sealant material temperature in degrees Fahrenheit at the wand once an hour during working production.
- 6. Beginning and ending locations on project for the day, including lane and direction.
- 7. The type and amount of materials used for the day in pounds including lot numbers.

To the Honorable Board of Supervisors, Green Lake County, Wisconsin.

We herewith submit our 2015 Annual Report for the Highway Commission for the period of January 1, 2015 through December 31, 2015.

The Green Lake County Highway Commission is responsible for year round upgrading, repairing and maintenance of 229 miles of County Trunk Highways and 70 miles of State Trunk Highways to ensure safe and efficient roadways for all travelers.

The Highway Commissioner directs the department consisting of 22 full-time employees, and 1 part-time employee. Operations are quartered in two locations. The main facility is located in the City of Green Lake with the second facility located in the Town of Manchester.

Some areas of specific responsibility include

- Reconstruction (grading/excavating, pulverizing existing pavement, placement of base materials, erosion control, paving, and marking & signing)
- Chip sealing
- Crack sealing
- Snow removal, ice prevention
- Sign installation and repair
- Guard rail and reflector maintenance
- Culvert replacement
- Bridge maintenance and inspection
- Drainage (clearing and cleaning culverts)
- Equipment repair and maintenance
- Issue permits (driveway, work in right-of-way, oversize, multi-trip, IoH)
- Natural disaster assistance (fallen trees and debris removal and barricading)

JURISDICTIONAL TRANSFER AGREEMENT

municipal corporation.			

RECITALS

WHEREAS, the County presently has jurisdiction of and maintenance responsibility for County Trunk Highway (CTH) Y located within the jurisdictional limits of the Town; and,

WHEREAS, the County and Town cooperatively negotiated the jurisdictional transfer of a segment of CTY Y located within the Town; and,

WHEREAS, the County and the Town agree to the jurisdictional transfer of the CTH Y segment as long as the conditions contained in this agreement are met and believe such transfer is in the best interests of the County and the Town.

NOW THEREFORE, in consideration of the promises and mutual obligations of the parties hereto, the County and the Town do hereby covenant and agree as follows:

- 1. Mutual Obligations.
 - a. The County agrees to remove from the County Trunk Highways system and the Town agrees to accept as part of the Town's roadway system, effective [insert date here], the following portions of the County Trunk Highway system:
 - i. CTH Y from a point West of STH 73 approximately 0.2 miles to Losinski Road
 - b. [any other mutual obligations go here]
- 2. County's Obligations.
 - a. The County will perform the following roadway improvements as part of this Jurisdictional Transfer. All work to be completed by 2017.
 - i. CTH Y From STH 73 to Losinski Rd: Widen road to 20 feet with 1 foot shoulders to match into existing Losinski Rd. Work to be completed consists of the following: regrading ditches, adding 4 to 6 inch gravel lift, pulverizing, and paving 0.20 miles with 4 inches of hot mix asphalt.

ii. CTH Y (South) & Losinski Rd Intersection: Remove "Y" intersection and install field entrance driveway.

3. Town's Obligations.

- a. The Town will accept jurisdiction of and maintenance responsibilities for the segment of CTH Y described within this Agreement (see 1.a.i.), effective [insert effective date here].
- 4. Notices. All notices, demands, certificates or other communications under this Agreement shall be sufficiently given and shall be deemed given when hand delivered or when mailed by first class mail, postage prepaid, properly addressed as indicated below:

Any Party may, by written notice to the other, designate a change of address for the purposes aforesaid.

- 5. This Agreement may not be assigned without the express written permission of the other party, which consent shall not be unreasonably withheld.
- 6. Each party has participated in negotiating and drafting this Agreement, so if an ambiguity or a question of intent or interpretation arises, this Agreement is to be construed as if the Parties had drafted it jointly, as opposed to being construed against a Party because it was responsible for drafting one or more provisions of this Agreement.
- 7. Severability. If any term of this Agreement is to any extent illegal, otherwise invalid, or incapable of being enforced, such term shall be excluded to the extent of such invalidity or unenforceability; all other terms hereof shall remain in full force and effect; and, to the extent permitted and possible, the invalid or unenforceable term shall be deemed replaced by a term that is valid and enforceable and that comes closest to expressing the intention of such invalid or unenforceable term.

- 8. Governing Law. This Agreement shall be governed by, construed and enforced in accordance with the laws of the State of Wisconsin.
- 9. Modification of Agreement. No amendment to this Agreement shall be valid and effective unless made in writing and signed by an authorized representative of each of the parties.

<u>Seasonal Road Posting for</u> Green Lake County's County Trunk System

Policy:

1. **Purpose:** Protecting local roads to prevent damage by heavy vehicles is the responsibility of local authorities. Imposing restrictions on vehicle weight limits is a reasonable and practical way to protect local roads when they are most vulnerable during the spring thaw. According to a national study by the Federal Highway Administration (FHWA), reducing truck weights by just 20% between late February and early May can increase the life of vulnerable pavements by 62%. Cutting weights in half increases pavement life by 95%. It can be a complicated process to analyze the capacities of pavements and bridges, therefore local authorities must use their judgement and knowledge of existing pavement conditions when imposing vehicle weight restrictions.

2. Damage caused by Freeze/Thaw cycle:

- a. **Frost:** When the weather gets cold, pavements and the water trapped within them freeze near the surface, moving deeper into the soil as cold temperatures persist and continue to fall. Frost depths may range from one or two feet during mild winters to five to eight feet during severe winters.
- b. **Spring Thaw:** In spring, roads begin to thaw from both the top surface and below the road base and subgrade. As ice in the pavement melts, water saturates the road's base and subgrade. As thawing continues, these layers lose strength, and, water is unable to drain away. Pavement weakens considerably in a very short time under these conditions.

Heavy Vehicle Damage: The amount of damage a road sustains is directly related to the weight of the load and how often it is applied, according to tests by AASHTO (the American Association of State Highway and Transportation Officials (AASHTO). Passenger autos and light duty vehicles are generally not the problem. Vehicles carrying legal weight loads of up to 80,000 GVW over weakened surfaces are the primary cause of damage. Furthermore, when vehicles carry loads that are heavier than the statutory weight limit, the potential for damage is much higher.

- 3. **Criteria for Posting County Trunk Highways:** Factors to consider when posting roads or segments include, but are not limited to:
 - a. *Pavement thickness:* Asphalt surfaces two inches thick or less, or total pavement less than 12 inches thick.
 - b. *Type of subgrade:* Fine-grained subgrade soils, like silts and clays, and areas with a high water table and poor drainage.
 - c. Past experience: Areas with alligator cracking or rutting that break up every year and need frequent patching and repair.
 - d. Amount and type of heavy vehicle traffic: Consider all heavy vehicle traffic, especially seasonally higher volumes carrying heavy loads. Another factor to consider is the amount of weight and number of tires on each axle. Damage increases rapidly with higher axle loads and actually worsens at a rate faster than the load increases.

- e. *Surface deflection:* Pavement sections where the surface deflects or bends 50% more during spring thaw than in summer. Also, increased deflection lower than 50% on weaker pavements where summer deflections are relatively high.
- f. Pavement age/condition: Weight restrictions can protect your investment in new pavements and prolong the life of weak or aging pavements.
- 4. **Authority:** Under section 349.16 *Wis. Stats.*, a temporary weight restriction may be imposed by the Green Lake County Highway Committee or the Highway Commissioner. The Green Lake County Highway Committee vests the Highway Commissioner with the authority to impose seasonal weight restrictions and issue special weight permits.
- 5. When to Post Roads: Spring weight limits should begin with the first thawing and continue until soils are completely thawed and the pavement is again strong enough to carry normal loads. Posting is weather dependent and dates may vary, starting from early March and ending by late April. Therefore, weight restrictions will become effective on County Trunk Highways, as determined by the Highway Commissioner, pending weather conditions and coordination with the Wisconsin Department of Transportation (WisDOT) and adjoining local road agencies.
- 6. **Communication:** An effort should be made to post road postings in the local newspaper and inform local haulers prior to posting. A letter should be sent to the previous year's multi or single trip permit applicants informing them of the upcoming posting restrictions. A description of the weight limits postings and a map illustrating the location of the postings may also be found under *Highway Department Seasonal Weight Restrictions* on the Green Lake County website. http://www.co.greenlake.wi.us. The map and posting of roads will be subject to change year-to-year at the discretion of the Highway Commissioner.
- 7. **Weight Limits:** Weight should be limited to 4 tons per axle, 10 tons gross on all posted County Trunk Highways, or as otherwise posted by the Green Lake County Highway Commissioner.
- 8. **Signing for weight restrictions:** Signs must be posted to give notice of the restrictions, and these signs must conform to the current *Manual on Uniform Traffic Control Devices* and the *Wisconsin Supplement* to that manual. Limits become enforceable as soon as signs are in place.
- 9. **Permits**: A single trip or multiple trip permit is required to haul on a posted road, and may be issued on a case by case basis. See Multi-Trip Permit and Terms and Conditions.
 - a. Special requirements may include:
 - i. Travel early morning or late evening verses mid-day
 - ii. Divisible loads
 - iii. Alternative route
 - b. Other considerations
 - i. Posted Bridges weight restrictions must be followed with no exemptions.
 - ii. Implements of Husbandry (IoH) Seasonal postings override any IoH permits issued.
- 10. **Exemptions:** Local weight limits override *all* special permits in the statutes. Public agency vehicles, milk haulers, public utility vehicles are not exempt from weight and size restrictions except as stated in *Wis. Stats.* ss. 348.17 and 348.18. Vehicles used to transport septic or holding tank material are

subject to *Wis. Stats*. s. 349.16(b). All other exemptions may be made by the Highway Commissioner, but should be consistent and reasonable.

- 11. **Enforcement:** State Patrol officers and County deputies are authorized to enforce weight limits. Green Lake County will be enforcing the posted seasonal weight limits and penalties may be imposed under §348.21 Wis. Stats. for violations.
- 12. **Damages to County Trunk Highways:** Under Section 86.02 Wis. Stats., a party which has caused damage to the highway is liable for triple the cost to repair the damages whether they have a permit or not.



The Pay Group for the General Laborer position is #12, the pay range is \$19.00 and goes up to \$24.27. Starting pay range will be \$19.00 - \$20.05. There are currently funds in the 2016 Budget to cover the expense of filling this vacant position.

• Necessity.

This position is required in order to maintain efficiency and productivity of the department during winter and summer maintenance.

• Evaluation of Existing Staff.

TITLE: HIGHWAY LABORER

DEPARTMENT: HIGHWAY

LOCATION: GREEN LAKE AND/OR MANCHESTER HIGHWAY BUILDING

SUPERVISOR: HIGHWAY COMMISSIONER AND/OR PATROL

SUPERINTENDENT

SUMMARY:

Under general direction, maintain State and County Trunk Highways, ditches and right of way so as to aid in the safe flow of traffic throughout Green Lake County; to perform reconstruction work as needed.

DUTIES AND RESPONSIBILITIES:

The percent of time spent on various jobs in the General Laborer classification can vary from job to job and season to season and within the season based on many variables that need to be taken into consideration. Given these elements of change, approximately:

- Snow and ice removal work, including putting up and taking down snow fence 20% of the time.
- Mowing, tree and brush control 15% of the time.
- Blacktop and shoulder work, including filling potholes 18% of the time.
- Flags and directs traffic when work is being conducted on roads 8% of the time.
- Rubber crack sealing 10% of the time.
- Patrol State and County Trunk Highways, clears debris and picks up litter 7% of the time.
- Drainage maintenance, including setting or assisting of setting culverts; cleaning culverts; may haul gravel or fill 5% of the time.
- Performs repairs on bridges, assists with annual inspections and other bridge work, as necessary 2% of the time.
- Operate heavy equipment 5% of the time.
- Assists in the upkeep, maintenance and repair of buildings, grounds and equipment. 10% of the time.
- Performs other work as assigned by the Commissioner or Superintendent 5% of the time.

SKILLS AND ABILITIES:

- General knowledge of methods, materials and equipment used in road construction and maintenance projects.
- Ability to use a transit; determine grade and proper slope for ditches and shoulders on existing roads.
- Knowledge, ability and skill in the use of measuring devices, assorted small tools
 that could be hand or power, motorized vehicles, earth moving equipment, air
 hammers, material handling equipment, tractors, mowers, front end loaders, snow
 removal equipment, grader, dozer, paver, rollers, sand blasters, backhoe, brush
 chipper, tar kettles, mechanical brooms and other similar equipment. Assorted
 personal protective equipment as required.
- Ability and skill to communicate effectively, both orally and in writing or with hand and arm signals.
- Ability to adapt to changing conditions.
- Ability to work flexible, 40 hour/week schedule to accommodate snow removal on weekends and emergency call-ins, as necessary.
- Ability to establish and maintain effective working relationships with co-workers, supervisors and the public.

QUALIFICATIONS:

EDUCATION: High School diploma or GED equivalency.

EXPERIENCE / JOB KNOWLEDGE: 1-2 years' experience working in road construction and maintenance, heavy equipment operation course, or equivalent combination of education and experience that provides the necessary knowledge, skills and abilities. Must possess and maintain a valid commercial driver's license (CDL) with A, B, C, D, and N endorsements.

WORKING CONDITIONS:

PHYSICAL DEMANDS: Given the variable and seasonal functions of this position, physical demands vary greatly from work assignments and seasonal demands. Approximately 75-90% of the time, depending on the actual work assignment, the employee will be performing work which could involve acute vision demands, walking, bending and twisting, feeling, standing, reaching, sitting, climbing hills or stairs, stooping, kneeling, verbally communicating, grappling, crouching, balancing, crawling and climbing ladders and getting on and off equipment are all required at various times and for various assignments. Good physical dexterity of arms and hands, legs and feet is necessary for accurate and safe operation of heavy equipment. Communications while working may be verbal. Good peripheral vision is necessary to assist the operator with maintenance and construction work as well as safety in work operations especially when working in traffic. Vision and hearing are important to this job as are hand and

eye coordination. Approximately 10-25% of a shift may be spent lifting and carrying up to 80 pounds, as required.

ENVIRONMENTAL DEMANDS: Up to 95% of work can be performed outdoors, exposed to seasonal weather elements, which could mean extreme hot, cold or humid conditions; 75% of work has exposure to noise or work involving vibration; 5% of work could be performed indoors. Hazards of this position include dangers from mechanical equipment, fast moving vehicles, heights, burns, fumes, mists or gasses, noxious odors, exposure to weather, dust, heat, equipment noise and fumes, electrical, and chemicals. May be required to work long or unusual hours as necessary to meet departmental needs.

This is a public service position, and employee is required to be courteous, cooperative and respectful at all times with the public and clients; also establishes and maintains a courteous and cooperative and respectful working relationship with other employees, supervisors and public officials.
