2013 FAIR UPDATES - DISCUSSION

Zills received the final 10% payment and gave the results to the Committee. She will make the updates, as stated from the Committee. As far as the Adopt-A-Pen, Zills received a \$555 grant from the Oshkosh Community Foundation and the total for the project as of now is \$11,355.00. Ghimire presented the Committee, on behalf of de Montmollin, with the Fair Superintendent's T-Shirt results. The cost of the t-shirts are \$14.75, with an extra \$2 charge for the larger sizes, from Custom Ink, which is an online source. A total of 37 are needed, but would like to also get extras, in case there is an increase in superintendents. *Motion/second (Schweder/Stoddard)* to approve the purchase of the t-shirts. - a. <u>Property & Insurance Committee</u> Stoddard reported that the Food Pantry project is completed on the interior. Maintenance will be removing the carpet. Stoddard read a thank you from the Food Pantry, thanking everyone for their hard work and dedication on the remodeling of the building.
- b. <u>Personnel Committee</u> Schweder reported they approved an increase in hours for the part-time secretary/floater position in the County Clerk's office from 1040 hours per year to 1500 per year. A notice from the US Department of Treasury and the IRS was received that modified the rule for health flexible spending arrangements. The rule was, use it or lose it every year and now employers can permit employees to use up \$500 of unused amounts in the next year. Approved filling the County Conservationist position.
- c. <u>Finance Committee</u> Reabe reported the property in Princeton has been sold and there are two properties in Berlin that are still waiting to be sold. They did approve the Committed Funds, which will go before the County Board in December for final approval.
