It was discussed that the way to move forward with the Creek issue is to work with Brian Disterhaft on a plan for restoring the creek and offer some alternative was to do this. 1. Clean and haul spoils to the Disterhaft property. 2. Clean and sidecast the vegetation. The best would be to start at Rustic Rd and go to the installed ditch plugs. Maybe the the proposal in 2 segments, the first being from Rustic Rd. to Hwy D and the second being from Hwy D to the plugs, if the cleaning of the first section does not work. This proposal will need to be submitted to Edwina. The board feels that it should be the DNR that is proposing the solution since it is there water that is illegally entering the district ditch.
