GREEN LAKE COUNTRY VISITOR'S BUREAU - LONI MEILBORG & ROGER FIELD

Roger Field and Loni Meiborg: Field explained that at the last EDC meeting the Visitor's Bureau was confused with the relationship between the GLCVB, EDC and Green Lake County. Meiborg presented the Annual Report of the GLCVB. She explained that they attended 5 trade shows this year and plan to attend the same shows next year. She stated that they also did a fund raiser of Kids from Wisconsin and they received about \$5000 because of sponsorships of the program. They also received a GEM grant from the State to promoted the Cranefest in Princeton. The Visitor's Guide was transitioned and well received. Other programs include a makeover of the Website, a relationship between county historical societies, use of Ripon

College internships, Chamber Director lunches and plans for a Discover Wisconsin 30 minute segment in 2015. In 2013 \$38.7 million in tourism dollars was spent in Green Lake County. Meiborg explained that they are operating in a deficit and are asking GLC to give an annual contribution of \$30,000. GLC currently gives \$12,500.

Field stated that some Counties have the Tourism director on the County payroll. If that were done the EDC would be willing to oversee the employee. GLCVB will come to the EDC/Finance Committee in May to discuss funding and budgeting.

RESOLUTION/ORDINANCES

• Res. 24-2014 Public Depositories: This is an update resolution which includes banks that the County has used for investments.

TREASURER'S MONTHLY REPORT

Amend presented her report to the Committee. Sales tax for November is \$146,344.84. Contracts have gone out to the Towns of Brooklyn, Kingston, Mackford and Marquette and the City of Princeton Green Lake for the Treasurer's office to collect the first installment of the property taxes.

Amend reported on her Wisconsin County Treasurer's Association Fall conference. The annual training meeting for the local municipal clerks and treasurers will be November 19th at 9:30 AM. *Motion/second(Meyers/Schubert)* to accept the Treasurer's Report. Motion carried.

DISCUSS 209 BROADWAY, CITY OF BERLIN TAX DEED PROPERTY

The building has a shared wall with the building next to it, so razing the building would present problems. The 2010 taxes have been paid so the property can no longer be taken this year.

DEPARTMENT HEADS REPORT – SHERIFF MARK PODOLL

Sheriff Podoll reported things are going well and Evans would provide the details. Evans explained 67% of expenditures have been spent overall. Some line items are over budget, but overall the expenditures are in line with the budget. The revenues are on track. Several lines were highlighted.

BUDGET REVIEW

Sarah Guenther sent a letter explaining the question regarding the Laredo and Tapestry revenue and expenditures for 2014 and 2015. More users are registered than anticipated so revenues are higher.

Revenues were reviewed by the Committee. Weatherization and parks donations were questioned.

Expenditures were reviewed by Committee. County Fair leases were questioned.

2015 BUDGET

The final draft of the 2015 budget was presented to the Committee. The budget is being sent out to the County Board members for their review prior to the Board meeting.

Supervisors' claims were presented in the amount of \$6,090.54 and Lay People in the amount of \$850.28. *Motion/second (Guden/Schubert)* to approve the supervisor's claims. Motion carried.
