Subject: ACTION ALERT: Senators Pushing to Repeal the ACA Before Sept. 30th

Importance: High

With less than two weeks to go before the expiration of the budget reconciliation rules which allow the Senate to pass a bill repealing the Affordable Care Act (ACA or ObamaCare) with only 51 votes instead of 60 (meaning no minority party votes are needed to pass the bill) several U.S. Senators, including Senator Ron Johnson (R-WI), introduced another plan last week to repeal and replace the ACA.

The Graham-Cassidy-Heller-Johnson (GCHJ) plan (also referred to as the Graham-Cassidy bill), like other previously rejected plans introduced by the House and Senate, would have negative consequences for the health and well-being of older adults, people with disabilities of all ages, and their families. The proposal replaces ACA tax subsidies and Medicaid expansion with block grants to states (scheduled to be eliminated in 2026) and places a per capita cap on the traditional Medicaid program (which funds Wisconsin's Family Care, IRIS, BadgerCare, and SeniorCare programs among others). The Graham-Cassidy proposal would:

- repeal the ACA's individual and employer mandates,
- significantly reduce Medicaid funding over the next 10 years,
- allow states to waive many of the ACA's consumer protections and allow insurers to charge sick or older patients higher premiums, and
- give states the option to let insurers exclude coverage of certain health care services (such as certain prescription drugs, preventive services, and mental health services).

Federal Medicaid fund cuts put older adults and people with disabilities who rely on Medicaid to remain living in their homes and communities at risk of losing coverage as states are forced to scale back services, create waiting lists, reduce payments to providers, or make changes to program eligibility.

The Congressional Budget Office (CBO) is expected to release a preliminary analysis of the bill early next week – see <a href="The Hill: CBO aims to release limited analysis of ObamaCare repeal bill next week">The Hill: CBO aims to release limited analysis of ObamaCare repeal bill next week</a>.

With pressure increasing to pass the Graham-Cassidy bill before September 30<sup>th</sup> and reports that 48 or 49 Republican Senators are believed to currently support the plan, aging and disability advocates are urging people to call their U.S. Senators now!

#### Take Action:

Contact Senator Ron Johnson (202) 224-5323 and Senator Tammy Baldwin (202) 224-5653 and let them know how Medicaid changes in the Graham-Cassidy-Heller-Johnson bill would impact you, your family, and/or older adults and people with disabilities in your community. Encourage them to work in a bipartisan manner to improve the health and well-being of all citizens and to ensure that older adults have affordable access to the heath care and coverage they need now and in years to come!
