REPORT ON TRI-COUNTY EDC

Bill Wheeler reported that the RLF consolidation resolution passed the Green Lake county Board, has passed the Waushara County Finance Committee and will be going to the Waushara County Board this month and that the Marquette County EDC discussed it at their last meeting and will be voting on it when the full EDC Board is present.

The Marketing Committee met on Thursday March 6th and are looking at developing signage that will be used in all three counties that will be recognizable. Discussion was held on filling the UWEX position in Green Lake County held by Jeff Hoffman who now works in Dodge County. Bostelmann will report to the Committee next month where the hiring process is and the County finance obligation for UEWX positions.

COMMUNITIES OF GREEN LAKE - MEMBERSHIP

Bostelmann explained that the Communities of Green Lake Board of Directors has looked at the concerns presented by the Green Lake Area Chamber of Commerce and have decided to make changes to address the concerns. The name will be changed back to Green Lake Country Visitor's Bureau and the executive director Sue McConnell has resigned.

Bostelmann also explained that Jacklyn Ewert contacted her to see if the EDC would like to co-sponsor the County map with the GLCVB. This would increase the number of businesses

that will be eligible for advertising and be included in the map. Currently only GLCVB members can be included.

Motion/second(Field/Priske) to authorize Bostelmann to work cooperatively with the GLCVB to produce the tourism map. Motion carried.
