**Staff Reports:** Hebbe welcomed two new LCC members. A written LCD staff report was distributed and reviewed.

#### Lake Reports:

**Little Green Lake:** The land survey for the land acquisition is complete.

**Green Lake:** The erosion control permit for Lindenwood Development has been issued but the permit for stormwater management has not been issued at this time. Hebbe and Al Shute, Land Development Director, are working closely with this.

**Puckaway:** A carp cage exclusion plot will be installed after the water level goes down.

**Other – Twin Lakes:** A \$75,000 DNR grant to control aquatic invasive species was awarded.

**Clean Sweep Program Update:** Hebbe reported that a DATCP grant request for the pharmaceutical collection program was denied. The LCC agreed that pharmaceuticals would still be collected at the Clean Sweep.

**Gypsy Moth Spray Program Update:** Hebbe reported that the egg mass hatch has begun. Within the next few weeks, the blocks should be sprayed.

**Summer Intern LTE Hiring Approval:** Interviews were held on May1 for the Aquatic Invasive Species summer intern. Three applicants were interviewed. Daniel Rieland was hired for the position. Supervisor Maureen Schweder participated in the interview selection. **Motion (Schure/McConnell)** to approve the hiring of Daniel Rieland as the LTE Aquatic Invasive Species summer intern. Motion carried.

**DATCP/County Cost-Share Contract Approvals:** **Motion (Traxler/McConnell)** to approve cost-share contracts for:
