**Staff Reports:** A written LCD staff report was distributed and reviewed.

**Little Green Lake Watershed:** A \$50,000 grant was received for sediment basin installation. Awaiting DNR permit approval for the project. Stoddard reported on the May 12, 2007 Little Green Lake Protection and Rehabilitation District annual meeting.

**Household Hazardous Waste Clean Sweep Contract Approval:** *Motion (Ammentorp/Schure)* to approve entering into the hazardous waste disposal contract with Veolia Environmental Services for the county's upcoming household clean sweep. Motion carried.

**Stormwater Maintenance Agreement – Joe Dispensa:** Hebbe read a letter sent to Joe Dispensa last month requiring that his property be brought into full compliance with Green Lake County Code § 284 Construction Site Erosion Control and Stormwater Management. A response was received but computations and the new operation and maintenance agreement were missing. The landowner will be given two weeks to supply the additional information, if it is not received in that timeframe, the County has the authority to hire an engineer to provide the needed information and charge the landowner for it.

**Public Comment:** Wally and Michele Szkwarko, neighbors to Joe Dispensa, commented that they too would like to see this storm water maintenance issue resolved.

**Mulcher Disposal:** *Motion (Hollander/Ammentorp)* to approve selling the department's mulcher at a county equipment auction. Motion carried.

**DATCP/County Cost-Share Contract Approvals:** *Motion (McConnell/Williams)* to approve DATCP cost-share contracts for Schurecrest Farms Inc - Roof Runoff Mgt \$161.10 (Upper Grand River Watershed); and Terrance & Beverly Hupf - Waterway System \$1,516.00 (Fox River-Berlin Watershed). Motion carried.

**Conservation Plan Approvals:** *Motion (Schure/Hollander)* to approve conservation farm plans for: Sandra James-owner/Keenan Dahlke-operator; Dale Justmann-owner/DuWayne Lohrey-operator; Roger Seymer; Patrick Burk; and Harold Drager-owner/Patrick Burk-operator. Motion carried.
