2011 Budgets

UWEX: Dean Slark appeared to discuss the budget. He explained that there was an error in the first draft of the budget and he presented the correct which was a reduction. The committee asked that they look at how UWEX can consolidated work with other departments or decrease the budget.

Land Use Planning & Zoning: Al Shute explained the LUPZ budget and projects that are planned. He explained how much this department has reduced the levy since 2000. He also explained that one employee was reduced from the department in 2009.

Law Enforcement: Podoll explained that the only increase is related to supplies based on P&I changed in accounting. Podoll explained why overtime has been decreased. Discussion on other ways the Sheriff is looking to reduce expense. Vehicles were also discussed.

Land Conservation: Hebbe explained the importance of Big Green Lake with regard to property value. He explained that his department works to keep the Lake value high through the programs that they administer. He also presented a graph showing how man hours are spent in his department. Questions were asked on specific line items an if there are areas that can be reduced.

Bostelmann explained that the Committee should not only be looking at expenditures, but also revenues to determine if revenues are being accurately stated. She also suggested looking at amounts of levy that are carried over for capitol items and if those items could be extended.
