# 2011 & 2012 DA BUDGET - KYLE SARGENT

Sargent explained that the VINE program was not included in the resolution listing committed fund for 2012. He stated that the Judicial Law/Emergency Management Committee thought that it was included. Sargent is asking how these funds can be allocated for the VINE program next year. Because the resolution was passed without the VINE project being named as a committed fund it can no longer be committed in 2012. Bostelmann explained that the County Ordinance which was passed in December allows for these funds to be assigned by the Finance Committee in 2012 for the VINE program. This can be done in February when funds for committed funds are allocated.

Sargent stated that the "Prosecution Services" is a line item in the DA budget. He would like to use \$2500 of the \$3000 in the line for the appointment of a student intern from the UW Law School prosecution project.

#### TREASURER'S REPORT

Morris sent her report to the committee. She also reported that the tax bills and tax rolls for most municipalities were completed by 12-9-11. All were completed by the 19<sup>th</sup>. She also presented the 2011 mill rate comparisons by municipalities and district.

Motion/second (Guden/Meyers) to accept the Treasurer's Report. Motion carried.

#### **BUDGET REVIEW**

The report was reviewed. Whirry questioned if the report can be modified to include more information. Discussion was held. Bostelmann will discuss possible changes in the report with Whirry.

Approve \$2500 of the DA budget line item for prosecution services be used for a student intern. *Motion/Second(Hedberg/Meyers)* to approve the budget adjust. 4 ayes, 1 abstain. Motion carried.

Request from Gary Podoll to increase the Terrorism expenditure and revenue \$30,621.13 because of the grant received.

*Motion/Second(Whirry/Hedberg)* to approve the increase in the Terrorism revenue and expense by \$30,621.13. Motion carried.
