# REFINANCING BONDS - BRIAN DELLA, PFM

Brian Della appeared to present information on refinancing the 2009A Notes and the 2011 BANs. Della explained the advantage of refinancing now with rates being lower than when the original borrowing took place. Discussion was held.

Motion/second(Meyers/Reabe) to approve sending two resolutions to the February 19th County Board meeting for refinancing the current bonds and State Trust Fund loan for the radio towers. Motion carried.

## TREASURER'S REPORT

Morris presented her report to the Committee. She reported that the Treasurer's Office has collected over \$8.7 million for the 5 municipalities that the Office collects for.

Morris also reported on the 2009 delinquent properties. The properties have been published in the paper. Morris reviewed her annual report with the Committee.

#### **ROD CHANGE FUND**

Guenther appeared and requested a change fund of \$30.00 to make change for customers in her office. *Motion/second (Guden/Reabe)* to approve the \$30.00 change fund for the Register of Deeds Office. Motion carried.

#### **BUDGET ADJUSTMENTS**

The Sheriff is requesting a revenue and expense donation account to accept donated funds to pay for a defibrillator in each of the Sheriff's Department squad cars.

#### **BUDGET REVIEW**

Discussion was held. Dissing explained he has looked into the intoxicated driver surcharge account since the last Finance meeting. He found that the surcharge is \$219 for each person who comes in for services. He presented a chart from 2004 to 2012 which indicated the conviction rate has been going down over the years. He also found that since the municipal court now exists, the money sent to the Treasurer's office has been going into a sheriff's office account. Dissing has spoken with the Sheriff and Lori Evans regarding the wrong account number being used. This will be corrected. Schubert thanked Dissing for his research into this account.
