ALTERNATIVE ROAD MAINTENANCE CHT S TO X - HIGHWAY

Buss explained that the County has not done much seal coating and this is a way for the department to help improve the road. Buss stated that this is expected to come out of the 2012 budget. If the budget goes over it will come to the Committee for approval for the funds to come from the Highway reserves.

Motion/Second (Meyers/Reabe) to approve the seal coating from the 2012 budget. Motion carried.

DISCUSSION COUNTY ROAD C TAX DEED PROPERTY

Morris reported her findings and cost regarding removing the trailer and abandoning the septic systems. Discussion was held. Sondalle explained that the Statue provides for the County to advertise the property under a Class 1 notice and accept a lower bid if a statement of explanation is provided. Morris will run a class 1 notice.

Motion/Second (Reabe/Guden) to run a class 1 notice advertising the property for one more week and then review any bids that may come in. Motion carried.

TREASURER'S REPORT

Morris provided her report. Whirry asked if the projected interest amount will be met this year. Morris thought it was too early to tell. She will review the investments that will be coming in this year and report back to the committee. Morris presented a detail of sales tax revenue and detail of the August 20th payout to the municipalities.

DEPARTMENT HEAD - MARK PODOLL, SHERIFF

Podoll appeared and asked if anyone had any questions on the printouts. Discussion was held. The Law Enforcement Budget is on track for the year.

BUDGET REVIEW

Meyers explained that the Veteran Service Commission's per diem and travel is taken from the Veteran Service Commission line item. Meyers would like to see \$1,000 added to the 2013 budget for the per diem and travel so the Veteran Service Commission funds can be used to help veterans.

Budget Adjustment for DA was discussed. A budget adjustment should be made for the grant projects. Bostelmann will talk with Sargent regarding this.

Bostelmann reported that at the County Clerk's annual conference representatives of the Wisconsin News Paper association and State Department of Administration appeared and discusses recent changes in the law regarding publication of public notices. Bostelmann will meet with Ty Gonyo of the Berlin Journal to discuss changes to help reduce publication costs. She will also discuss this will all county department head who publish legal notices.
