**Seneca-Warren Drainage Ditch – Ditch Cleanout Waushara County Portion:** The Board is not planning to address this portion of the ditch until the other portions are cleaned further downstream. Bob Nighbor mentioned that he is interested in cleaning out his portion.

**Seneca-Warren Drainage Ditch – Main Ditch Cleanout:** Jim Hebbe will call Jim Holzward about cutting the bank on the DNR land.

**Seneca-Warren Drainage Ditch - Lateral A Cleanout:** LaVern Alf feels that the spoil would be best on the north side to help with ditch maintenance. Disterhaft will contact Leon Petraszak about cost for the various ditch cleanouts.

**Seneca-Warren Drainage Ditch – Cleanout Timetable:** A special meeting may be called in October if the DNR permit arrives earlier than the planned October 19<sup>th</sup> meeting. Disterhaft will report on Leon Petraszak's workload and scheduling.

**Seneca-Warren Drainage Ditch – Brush Maintenance:** The Board will put this on the agenda in 2012.

**Drainage District Assessments:** *Motion (Albright/Disterhaft)* to set the assessment the same as last year for Districts #1, #2, #3, #4, & Seneca-Warren. Motion carried.
