**Land Conservation Committee**  
**August 12, 2021 Monthly Staff Report**

**July Projects**

1. Monitor current erosion control permits for compliance with county ordinances and review new permit applications for erosion control and storm-water management.
2. Completed construction of an underground outlet in the Town of Green Lake.
3. Assist Jerry Stanuch (GIS) in locating and surveying manhole covers using our survey equipment so he can create a map for the Sanitary District.
4. Completed the Green Lake County Transect Survey for remaining lands that were idle during first survey (late-planted fields).
5. Visit several sites of new boathouses per zoning request to give input on erosion control measures and help to implement BMP's.

**August Project Focus**

1. Continue to monitor existing erosion control permits, and review and issue new erosion control and storm-water management permits for applicants.
2. Begin construction of a grade stabilization structure, rock-lined waterway, and two grassed waterways in the Town of Green Lake once wheat is harvested.
3. Begin construction of a grade stabilization structure, rock-lined waterway, grassed waterway, and outlet protection in the Town of Green Lake.
4. Complete design for basin cleanout in the Town of Green Lake.
